- 1. Rental Duration: 24-hour rental period. Additional charges apply for late returns.
- 2. Full Service: \$50 fee for drop and \$50 for retrieval of equipment

- 5. Late Fees: \$30.00 per hour

- 8. Trailer is not permitted to cross state lines. (Unless customer asks ahead of time & gets approval from owner/manager)
